Entry Requirements - Philippines

Entry Requirements have been set in place to ensure that all individuals who gain entry into a Nationally Accredited Program have the appropriate skills and abilities they require to be successful in their studies.

Some courses may have higher entry requirements, please check specific course brochures for more information.

The following outlines entry requirements for international students intending to undertake study at Queensford College.

English language requirements maybe exempted if the student, please refer to our website for details.

Mature Age Students who do not have any qualifications, must pass the Queensford College internal LLN/ English Placement test

ACADEMIC REQUIREMENTS

Certificate III Level:

- have completed at least an Australian year 11 or equivalent.
- must pass Queensford College's internal LLN/ English Placement test.

Certificate IV, Diploma and Advanced Diploma Level:

- depending on upon the nationality of the student year 11 (Australian equivalent year 11) may be sufficient - please check with Queensford College prior to enrolment
- have completed at least an Australian year 12 equivalent
- must pass Queensford College's internal LLN/ English Placement test

ADDITIONAL REQUIREMENTS

- Satisfactory completion of K12 or overseas equivalent (recent K12 graduates are most preferred), or
- Students must have completed a Bachelors degree
- Mature age students (21 years or over) may be assessed for entry on a case-by-case basis (by providing a Resume/CV highlight relevant work experience). Applicable for Onshore Students
- Maximum Age: 30 year* (Exceptions Applicable as long as its demonstrated and the College is satisfied).

Entry Requirements - Philippines

ENGLISH LANGUAGE PROFICIENCY LEVEL

Certificate III Level:

- students must provide evidence of attaining an overall IELTS score of 5.0 or equivalent scores on a similar test (such as TOEFL, PTE etc.); or
- attained at least Intermediate Level of English and must provide evidence of the same; or
- student must pass Queensford College's relevant Internal English Placement Test

Certificate IV, Diploma and Advanced Diploma Level:

- students must provide evidence of attaining an overall IELTS score of 5.0 or equivalent scores on a similar test (such as TOEFL, PTE etc.); or
- attained at least Intermediate Level of English and must provide evidence of the same; or
- student must pass Queensford College's relevant Internal English Placement Test

ADDITIONAL REQUIREMENTS

- Students with experience in similar/different fields carries a lot of weight in choosing the course.
- Resume/Curriculum Vitae needs to be submitted.
- Evidence of continuously training themselves is highly recommended.
- Payslips, Recommendation Letters needs to be submitted.

Statement of Purpose (SOP)

WHAT TO INCLUDE IN A SOP

- A brief introduction about yourself and your family.
- Your educational, employment history and information about any English test taken.
- Your reasons for not choosing your home country to undertake further studies.
- Your reasons for choosing Australia as a study destination (students must specifically write reasons about not choosing other countries such as USA, Canada, UK, New Zealand etc).
- Reasons for choosing a particular city in Australia.
- Information about why you intend to study a particular stream.
- Your reasons for choosing Queensford College (students must specifically write reasons about not choosing other colleges including the names of the colleges that you considered in the process).
- Knowledge about the course/s you are going to study.
- What are your future plans after completing these course/s (we expect students completing diploma and advanced diploma to go further and study bachelors degree – students must mention specifically the respective bachelors degree and the university they intend to further study).
- What is the job title you are seeking to gain in your home country after completing the studies in Australia.
- Demonstrate knowledge about the visa regulations and ties to home country.

Note: SOP Genuine Temporary Entrant (GTE) statement is to be at least 3 - 4 pages in length covering the above aspects

Financial Documentation

LIST OF FINANCIAL DOCUMENTS REQUIRED

- Relationship Certificate with Sponsor/s
- Sponsorship Letter from Sponsor/s
- Education Loan or Bank Balance Certificate
- Income Proof with Income Tax submissions
- Property valuation from appropriate office
- Tax Clearance Letter (If applicable)

Note: All documents should be translated in English from Notary Public Lawyer

Enrolment Process

College Assesses and Verifies Applications

Once we receive the student's application we will assess their application against the requirements of the course and issue a conditional offer letter, which is followed by an interview with student and financial documents verification.

Electronic confirmation of enrolment (eCOE) will be issued.
